Compact Mobile Food Operation (CMFO) Requirements and Guidelines

To operate a <u>Compact Mobile Food Operation</u> (CMFO) on the UC Davis campus, vendors must obtain the necessary permits and comply with all applicable legal and policy requirements, including UC policies and procedures. These include requirements and guidelines for utilizing approved campus space and respecting the rights and responsibilities of the campus community. CMFO's failure to comply with applicable legal and policy requirements may result in enforcement up to and including complete loss of privileges to operate on the UC Davis campus.

Health and Safety Permitting

CMFOs are legally required to obtain a permit to operate on the UC Davis campus. For health permit
approval to operate on the UC Davis campus, follow the process described here and/or contact UC Davis
Environmental Health and Safety at REHS@ucdavis.edu or 530-752-1493.

Campus Access

- Per <u>UC Davis policy PPM 270-23</u>, Dining Servies has operational oversight of all food service on the UC Davis campus. CMFO providing services on the UC Davis campus must engage with Dining Services and will be required to provide contact information, business plans, and service schedule.
- CMFO must only operate in approved locations (see <u>campus map</u> identifying these locations).
 - o ARC Patio
 - Storer Mall at Storer Hall
 - Mondavi Center Courtyard
 - Howard Way at North Quad
 - Sprocket and California
- UC Davis has the right to limit the amount of CMFO permits issued annually.
- UC Davis has the right to limit the number of CMFO carts operating at the same time at any approved location to mitigate safety related congestion issues.
- CMFO must avoid serving in restricted areas: including Student Housing and Dining Services controlled areas, the Memorial Union patio and Quad, and the Silo patio. During Campus Community Events, an event invitation, and coordination with the campus event planner, will be required to participate.
- CMFO must only operate on hardscape and not lawn areas.
- CMFO must have a valid parking permit for any vehicles parked on site while on campus.

State and Federal Working Requirements

 CMFOs must be in compliance with all applicable federal, state and local working conditions requirements.

Safety Requirements

- CMFO are required to have a valid fire extinguisher and first aid kit on hand.
- CMFO must adhere to all vehicle safety laws while on university property.
- CMFO must not block any building egress pathways.
- CMFO must not block any identified fire lanes, sidewalks, or bike traffic lanes.
- CMFO must not cause hazards to the university property such as leaking oil, exhaust fumes near the building's air intake or windows, or have excessively loud generator or amplified sound.
